

The platform is an integrated, QR-driven compliance and workforce management system built to align with Industry 5.0 principles – putting the worker at the centre while automating regulatory and operational compliance. It separates personnel and inanimate assets (tools, plant, equipment) while interlinking them through unique QR codes. This enables real-time compliance checks, location tracking, training allocation, and safety management across the entire organisation.

Core Capabilities:

- · Fully modular and customisable to specific company policies, procedures, and compliance criteria
- · Automated onboarding and profile generation
- · Centralised admin layer with live oversight of personnel, assets, training, wellness, and compliance
- · Bi-directional data flow between employees and assets, enabling smart operational and safety decisions
- Real-time compliance checks via QR scans (e.g. is this worker qualified to use this equipment?)
- Engagement and recognition system to incentivise participation and safety culture
- · Built-in request & approval workflows for training, asset access, certification, and procurement

Onboard Personnel

Purpose: Seamlessly onboard new employees and create their personal compliance profile with dedicated QR code. Key Features:

- Role assignment with embedded policy/task checklists

- Admin control for progress monitoring
- Fully automated policy and induction task issuance

Benefits: - Accelerates onboarding timelines - Ensures standardised, role-specific induction - Links employee to all other compliance apps via QR profile

Why It Matters: Workers can get started faster and safely, with all required onboarding tasks monitored and recorded. HR and compliance teams gain visibility and confidence in readiness-towork status.

Qualification Tracker

Purpose: Seamlessly onboard new employees and create their Purpose: Track qualifications, identify gaps, and ensure compliance with role-specific requirements.

Key Features:

- Upload and validate qualifications/certifications
- Real-time comparison with role or task requirements
- · Automated alerts for expiring or missing credentials
- Link to XR2train LMS for resolving gaps
- · Supervisor dashboard to oversee workforce competency

Wellness Coach

Purpose: Empower employee wellbeing through daily check-ins, peer support, and resource access.

Safety Comms

Purpose: Two-way safety communication and reporting system between workers and the organisation.

Key Features:

- Receive push notifications for safety updates, notices, seminars, briefs
- Submit safety observations, incidents, near misses, good practices
- · QR code scanning to access on-the-job safety briefs and alerts
- Log scan activity for insight into workforce engagement
- Track who reads safety notices (when, where, how often)
- Gamified recognition for observations and engagement (leaderboards, awards)
- Fully traceable safety comms record for compliance and audit

Benefits: - Creates a culture of proactive safety reporting - Delivers fast, targeted communications to the right people - Shows who saw what, when, and where.

Why It Matters: Communication is a critical pillar of safety. This app bridges the gap between top-down notices and frontline insight, ensuring safety is everyone's responsibility.

Asset Manager

Purpose: Manage all non-personnel assets (owned or rented) to ensure operational and safety compliance.

Key Features:

- Register all plant, tools, and equipment
- · Assign unique QR code to each asset
- Track inspection/certification status
- · Set automated alerts for inspections, renewals
- Location tracking and booking system
- Qualification check before asset use (compliance gate)
- · Asset condition reporting and maintenance log
- Admin workflow for approvals on bookings/purchases/ replacements

Benefits: - Prevents unauthorised or unsafe equipment use -Ensures inspection and certs are always current - Optimises asset usage and reduces downtime

Why It Matters: Assets and people are connected in your operations. This app ensures that both are matched, qualified, and working within compliance every day.



Our Applied Intelligence Platform brings together six interconnected apps to automate and personalise compliance across the workforce, all while aligning with Industry 5.0 values that put human wellbeing at the heart of operations.

Every worker and asset in your organisation is assigned a unique QR code, enabling real-time traceability, qualification checks, training assignments, asset bookings, and access control. From onboarding to asset management, our system ensures that compliance is always current, visible, and actionable.

The platform delivers three interlinked flows of compliance:

- 1. Personal Compliance through onboarding (Onboard Personnel), qualification tracking (Qualification Tracker), and training (XR2train LMS).
- 2. Safety Compliance through wellbeing monitoring (Wellness Coach) and real-time, two-way communication (SafetyComms).
- 3. Operational Compliance through asset control and inspection management (Asset Manager).

Overseen by a central Admin Layer, the system offers live dashboards, trend analytics, approval workflows, and configuration to your policies, sites, and roles.





New Recruit - Electrician (Field Role)

Objective:

Ensure the worker is fully compliant, trained, and connected before starting high-risk electrical tasks.

Journey:

Day 1 - Onboard Personnel

- · Registers as a new starter
- Completes onboarding tasks (e.g. site rules, PPE policy)
- Role assigned: Electrician
- Personal QR code issued

Day 2 - Qualification Tracker

- Uploads certifications: ECS, 18th Edition, IPAF
- System checks role compliance
- One qualification missing: Asbestos Awareness flagged

Day 3 - XR2train LMS

- Takes Asbestos Awareness via e-learning
- Completes Lock-out Tag-out XR scenario
- System updates QTapp


Day 4 - Asset Manager

- Scans asset QR for boom lift
- System checks qualifications → access granted
- Logs asset condition via app

Ongoing

- Receives weekly toolbox talks via SafetyComms
- Reports unsafe electrical setup via SafetyComms (+ recognised for observation)
- Logs daily wellbeing check-ins (Wellness App)
- Tracked as "green" status for compli





Senior Site Manager – Project-Based (Manager Role)

Objective:

Oversee worker safety, asset allocation, and training compliance across a site team of 80+.

Journey:

Week 1 - Onboard Personnel

- · Onboarded as a senior manager
- Assigned compliance dashboard access for "Site A"
- QR code issued and team visibility activated

Ongoing - Admin Layer

- Views compliance status of team (traffic light system)
- Flags 4 team members needing training refreshers
- Assigns refresher via XR2train LMS
- · Receives notification when complete

SafetyComms

- Issues site-wide safety bulletin for upcoming crane lift
- Tracks who viewed/read the alert
- · Follows up with non-respondents


Asset Manager

- Reviews daily asset bookings
- Approves requests for MEWP and cutting equipment
- Flags plant needing service based on usage logs

Wellbeing App

- Monitors anonymised wellness trends
- Notices rise in fatigue reports \rightarrow schedules resilience microcourse for entire team





Canteen Worker - Support Role

Objective:

Onboard and maintain minimal but necessary compliance for a low-risk support role.

Journey:

Day 1 - Onboard Personnel

- Onboarded and issued QR code
- Assigned policies (hygiene, site access, PPE)

Qualification Tracker

- Uploads food hygiene certificate
- System marks role as compliant

XR2train LMS

- · Optional: completes site orientation e-learning
- Wellness micro-learning available but not mandatory

SafetyComms

- Receives alerts about fire drills, site access changes
- Occasionally reads safety stories from other departments

Wellness App

- Logs stress and tiredness 2 days in a row
- Buddy system suggests check-in with line supervisor
- Resilience content automatically suggested





Temporary Contractor – Groundworks Specialist (Short-Term, High-Risk Task)

Get fully compliant for a specific task with minimal delay, and ensure task-related safety and qualifications.

Journey:

Pre-Day 1 – Onboard Personnel (via external access link)

- Contractor pre-registers and uploads ID
- Assigned temp role: Groundworks Specialist
- Receives QR code on arrival

Day 1 - Qualification Tracker

- Uploads CSCS card, Excavator cert
- Lacks Confined Space Entry \rightarrow flagged

XR2train LMS

- Completes Confined Space Entry e-learning module
- Assigned Trenching and Shoring Safety XR module for the afternoon
- System auto-updates compliance profile

Asset Manager

- Attempts to book trench support equipment
- Approval request goes to supervisor (hold point)
- Approved, equipment logged as "in use"


During Work

- Receives a dynamic SafetyComms alert: "Heavy rain excavation risk updated"
- Scans QR for updated method statement
- System logs view and location

End of Week

- Submits incident report via SafetyComms for soil collapse risk
- · Recognised with engagement award





Expanded System Capability: New Starter Asset Assignment

When a new employee is onboarded through Onboard Personnel, they are:

- Assigned a role
- Assigned a QR-linked digital profile
- Automatically issued relevant person-specific assets via AMapp, including:
 - PPE (e.g., boots, helmets)
 - Site access card / ID
 - IT equipment (e.g., laptop, tablet, phone)
 - Software licenses or login credentials

These are:


- Logged under the worker's profile
- Linked via QR codes for tracking and compliance
- Managed with expiry/inspection schedules (e.g., software licenses, PPE lifecycle)

A supervisor can approve or manually adjust asset assignments based on role or special needs.

The system generates alerts for:

- Missing returns (end of contract/termination)
- Upcoming replacements
- Maintenance/service for IT devices
- Security risks for unreturned access cards
